As a cooperative member, you are entitled to deduct <u>your proportionate share of the Cooperative's real</u> estate taxes and the Corporation's interest on your Federal Income Tax return, <u>if you itemize your</u> deductions. You may also deduct <u>Real Estate</u> taxes from your Illinois tax return. Our bookkeeper calculates Senior Exemption refunds. <u>Senior citizens who received a Senior Exemption check from the</u> co-op must deduct that amount from their total Real Estate tax deduction.

For shareholders who are not seniors, our bookkeeper has calculated the amount you can deduct for Real Estate Taxes on your <u>2023</u> return. This amount is equal to the number of months in <u>2023</u> for which you paid carrying charges to the Cooperative, multiplied by the amount in the REAL ESTATE TAXES column below opposite the amount of your MONTHLY CARRYING CHARGES for <u>2023</u>. The amount you can deduct for the interest is calculated in the same manner, using the INTEREST column.
